The functions of Advisory Council would be:-

- i) To advise for a comprehensive, holistic evolution of Higher Education sector.
- ii) To strategize and steer the expansion of Higher Education.
- ii) To evolve new concepts and programmes in Higher Education.
- iii) To provide common facilities in Higher Education without impinging upon the autonomy of other institutions of Higher Education.
- iv) To provide academic input to the Government and to the Universities, research institutions and other centers of Higher Education in the State for the formulation and implementation of the policies and evolve a perspective plan for its development, suo moto or on the suggestion from Government or requests from Universities or other institutions.
- v) Undertake independent research for the generation of new ideas for the promotion of social justice and academic excellence in Higher Education.
- vi) Undertake human resources development planning for the State and plan the growth and development of Higher Education in accordance with such planning.
- vii) Evolve programmes in order to promote the relevance of Higher Education for the economic, social and cultural development of the State.
- viii) Suggest improvements in curriculum and syllabi in accordance with the changing societal and academic requirements and facilitate the development and publication of appropriate teaching material, including text books, educational softwares and e-learning facilities in order to improve the quality of education.
- ix) Advise the Government on the start of new courses, colleges and other Higher Education institutions in the State.
- x) Evolve schemes for providing equitable opportunities for Higher Education and scholarships and freeships and financial assistance to the needy students and coordinate implementation of Scheduled Castes and Scheduled Tribes and other eligible backward classes welfare programmes of the central and the State Government and other Central and State Level Funding Agencies.
- xi) Review periodically the Statutes, ordinances and Regulations of the Universities in the State and suggest appropriate improvements for the realization of the objectives of social justice and academic excellence in education and suggest the frame work for new statutes, ordinances, or Regulations for existing Universities or other institutions of Higher Education or new Universities or other institutions of Higher Education.
- xii) Promote sports and cultural activities in the colleges, other institutions and Universities and integrate them with the co-curricular activities.
- xiii) Evolve schemes to sensitize the students to environmental and gender issues.

- 14) To promote framework for institutional accountability through proper regulatory system.
- 15) To advise Improvising the standards of Examinations and suggest reforms.
- 16) Devise mechanism for social audit process and public feedback on performance and achievements.
- 17) To assess the existing infrastructural facilities of the institutions and shall provide or cause to be provided additional facilities wherever required.
- 18) To promote research, the Council will encourage coordination between State Universities and other Universities of the country and abroad.
- 19) To develop programmes for greater academic cooperation and interaction between University Teachers and College Teachers.


