Objectives:

The Council would function as an independent and autonomous body of the State Government to achieve the following objectives:

- to plan and coordinate development of Higher Education of the state with the National Implementing Agencies and State Departments/Universities/Colleges and Other Agencies;
- 2. to foster resources sharing between various stakeholders and institutions functioning in the state;
- 3. to create synergy between the institutions across the state;
- 4. to lead and reform academic governance issues at the institutional levels;
- 5. to establish modalities for funding of the institutions in the state;
- 6. to maintain a database on higher education, monitoring, evaluation and research in higher education sector of the state;
- 7. to promote the use of teaching technologies among the higher education institutions (HEIs) in the state.
- 8. to decide and implement strategies for the growth and continuous qualitative improvement in the higher education sector of the State, from time to time, as per requirements;
- 9. to aid and advice the State Government on various issues that are referred to the Council by the Government, from time to time, as per requirements.
- 10. to ensure the full implementation of RUSA norms and guidelines in the state.





To achieve the above stated objectives the State Higher Education Council (SHEC) will have the following Powers and Functions:

Strategy and Planning

- Preparing the State Higher Education Plan (Annual Plan and Budget and Perspective Plan.)
- Providing inputs to the State institutions for preparing their plans and implementing them.
- Coordination between apex bodies, regulatory institutions of the nation and State Governments.
- Promoting use of technology in learning especially deployment of ICT tools.

Monitoring and Evaluation:

- Monitoring the implementation of State Higher Plan.
- Creating and maintaining the management information systems.
- Compiling and maintaining periodic statistics of State and Institutional level.
- Evaluating State institutions on the basis of norms and indicators developed under RUSA (the Council may, for its own use, developed additional norms as it thinks fit).

Quality assurance and academic functions:

- Faculty quality enhancement initiatives.
- Quality of examinations.
- · Maintaining quality of curriculum.
- Promoting innovation in research.
- Protecting the autonomy of state institutions.

Advisory functions:

- Advising State Government on strategic investments in higher education
- Advising universities on statute and ordinance formulation.
- Advise on matters of regulation of existing private institutions and permission to new ones.
- Advise on Open and Distance Education (ODE) strategies.

Funding Function:

- Fund managed by the Higher Education Council will come from RUSA as well as the State Government.
- Determine the methodology for timely transfer of RUSA funds along with state's share to institutions.
- Disburse funds to state universities and colleges on the basis of the State Higher Education
 Plan with transparent norms and in transparent manner.
- To obtain timely utilization certificates of funds from individual institutions, and submission of the same to the RUSA Mission Authority.
