ORDER

The Governor of Arunachal Pradesh is pleased to accord administrative approval and expenditure sanction not exceeding to ₹ 270.00 lakhs (Rupees Two Hundred Seventy Lakhs) only being release of Central Share against the financial year 2013-14 as Preparatory Grants under RUSA to State Higher Education Council of Arunachal Pradesh during the financial year 2014-15 as per appendix 'A' subject to the restriction of fund as per actual availability during CFY 2014-15 and observance of all codal formalities, ensuring guidelines of State Govt./GOI/GFR which shall squarely be the responsibility of the Department and conditions stipulated as under:

1. The amount sanctioned as Grants during the financial year 2014-15 shall be utilized during the current fiscal for preparatory activities like capacity building, Planning etc. as per guidelines of RUSA.
2. Utilisation Certificate of Grants-in-aid should be furnished after closing of the current financial year.
3. The accounts of the Council should be furnished after duly audited by registered Charter Accountant after closing of the current financial year.
4. The Finance & Accounts Officer of the Directorate of Higher & Tech. Education, Itanagar who is the Drawing and Disbursement Officer is authorized to draw the sanction amount in favour of SHEC (RUSA) Arunachal Pradesh by Bank Draft for onward deposit the amount into the SHEC (RUSA) Bank Account.

The expenditure is debit to the Demand No. 75, Major Head 2202 General Education, Sub-Major Head – 03, University & Higher Education, Minor Head – 800– Other Expenditure, Sub-Head (03) 08 – Rashtriya Uchchatar Shiksha Abhiyan , Detailed Head – 00 Object Head – 29 – Grant-in-aid-General , Code 02 (Plan).
