ORDER

The Governor of Arunachal Pradesh is pleased to accord expenditure sanction not exceeding to **Rs 49.50 lakhs (Rupees Forty Nine Lakhs Fifty Thousand)** only being the 1st installment of Central & State Share released by MHRD, Govt. of India and Govt. of Arunachal Pradesh for Upgradation of Commerce Block of Dera Natung Govt. College, Itanagar under Rashtriya Uchchar Shiksha Abhiyan(RUSA) scheme during 2015-16, against the estimated cost/ administrative approval not exceeding **Rs 100.00 lakhs (Rupees One Hundred lakhs)** only through Engineering Wing(Education Department), Itanagar, subject to availability of fund and observing of all codal formalities with the conditions stipulated under:-

1. The Expenditure during 2015-16 is restricted to **Rs 49.50 lakhs (Rupees Forty Nine Lakhs Fifty Thousand)** only, subject to existence of Budgetary provision during the current financial year under the concerned Head of Account.
2. The project should be completed as per original scope concept paper and specifications and no revision of the estimate is entertained.
3. The funds should be utilized within specified time and strictly for the purpose for which it has been sanctioned. No diversion of the fund is allowed.
4. Out of 3% contingency charges 1% shall be used by the Department for payment of water charges, power charges, land revenue and telephone bills under intimation to Finance Department (Budget).
5. The concurrence is subject to non-duplication with any other schemes. Any deviation would be responsibilities of the Department.
6. The selection of the works/scheme and its execution shall be as per guidelines of Government. Construction of works and procurement of materials shall be made as per GFR.
7. The validity of the sanction is subject to the existence of Budgetary provision in subsequent years, if any.
8. Necessary deduction be made for Royalty, VAT and labour Cess and deposited in proper Head of account as referred in Govt. order No. BT-339/2009/pt./622, dated 25.07.2012.
9. The Department shall deduct TDS of VAT on works contract @ 12.5% leviable on taxable turnover of the works contract vide ordinance No. TAX-64/2004/Pt., Dated 28th Aug' 2009 or if opted by contractors, as per new schemes of 4% on total turnover issues vide Notification No. Tax-28/2002/Vol-II, Dated 31st Aug' 2009 of Department of Tax & Excise.
10. The above concurrence is subject to the following of all codal formalities and ensuring guidelines of State Govt/Gol which shall squarely be the responsibility of the Department.
11. The Department should obtain authorization for issuance of LOC by works Department, Forest Department and also final payment by Govt. order No. DAT/TRY/51/2013/544-624, dated 4th Sept. 2014.
12. This concurrence is subject to the following of all codal formalities conditions and ensuring that all conditions laid down in GFR, DFPR etc. financial rules and regulations, circulars, direction & guidelines etc. issued by the Govt. of India, Ministry of finance/CVC and Govt. of Arunachal Pradesh from time to time are followed in letter and spirit without fail in this regard. This shall squarely be the responsibility of the department.
