ORDER

The Governor of Arunachal Pradesh is pleased to accord administrative approval and expenditure sanction not exceeding to **Rs 125.00 lakhs (CS:Rs.112.50 Lakhs & SS:Rs.12.50 Lakhs)** only being the 2nd installment of Central and State share released by MHRD, Govt. of India and Govt. of Arunachal Pradesh to Donyi Polo Govt. College, Kamki, West Siang under Rashtriya Uchchar Shiksha Abhiyan(RUSA) scheme during the FY 2016-17 for the following works to be executed through the Executive Engineer, Engineering Wing, Education Department and the Executive Engineer, PWD, Yomcha Division, West Siang, Arunachal Pradesh :

1. The Expenditure by the executing agency during 2016-17 is restricted to **Rs 125.00 lakhs (Rupees One hundred twenty five lakhs)** only, subject to existence of budgetary provision during the current financial year under the concerned Head of Account.
2. The project should be completed as per original scope concept paper and specifications and no revision of the estimate is entertained.
3. The funds should be utilized within specified time and strictly for the purpose for which it has been sanctioned. No diversion of the fund is allowed.
4. The concurrence is subject to non-duplication with any other guidelines of Govt. and any deviation would be responsibility of the Department.
5. The selection of the works/scheme and its execution shall be as per guidelines of Government. Construction of works and procurement of materials shall be made as per GFR.
6. The above concurrence is subject to the following of all codal formalities and ensuring guidelines of State Govt. / Gol which shall squarely be the responsibility of the Department.
7. The Department shall deduct TDS of VAT on works contract @ 12.5% leviable on taxable turnover of the works contract vide ordinance No. TAX-64/2004/Pt., Dated 28th Aug' 2009 or if opted by contractors, as per new schemes of 4% on total turnover issuesa vide Notification No. Tax-28/2002/Vol-II, Dated 31st Aug' 2009 of Department of Tax & Excise.
8. All codal formalities, all the provisions and conditions prescribed in GFR, DFPR, CPWD manual etc. all the financial rules and regulations, the guidelines and directives issued by Govt. of India, Ministry of finance/CVC and Govt. of Arunachal Pradesh from time to time are to be followed in letter and spirit without fail.
9. The execution of works/ schemes /projects and procurement of item/materials, furniture's etc. and erection/installation of tents, stage lighting, sound system and purchase of stationary items, printing materials etc. should be done strictly as per the provision of GFR, DFPR, etc. and guidelines and conditions prescribed by the Gol, CVC and Govt. of Arunachal Pradesh in this regard from time to time. To ensure transparency, the process of tendering and competitive bidding should mandatorily be followed and compiled with as envisaged in GFR, DFPR, financial rules and regulations and the conditions, guidelines, circulars and directives issued/prescribed by Govt. of India, CVC and Govt of Arunachal Pradesh in this regard.
10. All the conditions and guidelines prescribed and specified by the Planning Department, Govt. of Arunachal Pradesh shall be followed in letter and spirit without fail.
11. All the conditions and guidelines and prescribed and specified by Ministry of DoNER /NEC/ Concerned Ministry, Gol shall be followed in letter and spirit without fail.
12. The Department should mandatorily follow all conditions as in the guidelines of RUSA Schemes and in the sanction order without fail for strict compliance.


