
ORDER

The Governor of Arunachal Pradesh is pleased to accord administrative approval and expenditure sanction not exceeding to **Rs. 200.00 Lakhs** (CS:Rs. 100.00 Lakhs & SS:Rs. 100.00 Lakhs) only being the 2nd installment of Central and State share released by MHRD, Govt. of India and Govt. of Arunachal Pradesh to Govt. Model Degree College, Palin, Kra-Daadi district for "**Construction of Model Degree College at Palin**" through RWD, Palin Division, Palin, Kra-Daadi District against the estimated cost/ Administrative Approval not exceeding Rs. 780.00 Lakhs (Rupees Seven Hundred Eighty Lakhs) only, subject to availability of fund and observing of all codal formalities with the conditions stipulated under.

1. The expenditure during the FY 2018-19 is restricted to **Rs. 200.00 Lakhs (Rupees Fifty lakhs)** only, subject to existence of budgetary provision during the current financial year under the concerned Head of Account.
2. The fund under Centrally Sponsored Scheme [CSS/NEC/NLCPR/BADAP and State Share related to CSS] shall be placed / transferred through PFMS Plat form mode only.
3. The project should be completed as per original scope concept paper and specifications and no revision of the estimate is entertained.
4. The funds should be utilized within specified time and strictly for the purpose for which it has been sanctioned. No diversion of the fund is allowed.
5. The concurrence is subject to non-duplication with any other guidelines of Govt. and any deviation would be responsibility of the Department.
6. The selection of the works/scheme and its execution shall be as per guidelines of Government. Construction of works and procurement of materials shall be made as per GFR.
7. The above concurrence is subject to the following of all codal formalities and ensuring guidelines of State Govt. / Gol which shall squarely be the responsibility of the Department.
8. The Contingency Charge shall be restricted to 1.5% for the cost up to RS. 3.00 Cr. And 1% for the cost above Rs. 3.00 Cr., and Scheduled of Rate shall be APSR 2018 as per Govt. Order No. No. Fin [D]-6/2003 Dated 27th Sept. 2018 and Govt. order No. Fin [D]-04/2018 Dated 05th Feb'2019.
9. The DDO of the Department should ensure to obtain the copy of GST return 3 B filed for the previous Tax period from the Supplier / Contractor before releasing any payment as per Govt. order no. GST/27/2017 Pt. Dated 3th Oct. 2018.
10. All codal formalities, all the provisions and conditions prescribed in GFR, DFPR, CPWD manual etc. all the financial rules and regulations, the guidelines and directives issued by Govt. of India, Ministry of finance/CVC and Govt. of Arunachal Pradesh from time to time are to be followed in letter and spirit without fail.
11. The execution of works/ schemes /projects and procurement of item/materials, furniture's etc. and erection/installation of tents, stage lighting, sound system and purchase of stationary items, printing materials etc. should be done strictly as per the provision of GFR, DFPR, etc. and guidelines and conditions prescribed by the Gol, CVC and Govt. of Arunachal Pradesh in this regard from time to time. To ensure transparency, the process of tendering and competitive bidding should mandatorily be followed and compiled with as envisaged in GFR, DFPR, financial rules and regulations and the conditions, guidelines, circulars and directives issued/prescribed by Govt. of India, CVC and Govt of Arunachal Pradesh in this regard.
12. All the conditions and guidelines prescribed and specified by the Planning Department, Govt. of Arunachal Pradesh and the Ministry of DoNER /NEC/ Concerned Ministry, Gol shall be followed in letter and spirit without fail.
13. The Department should mandatorily follow all conditions as in the guidelines of RUSA Schemes and in the sanction order without fail for strict compliance.
