Sub:- Release of Grants to **Arunachal Pradesh** for Infrastructure Grants to 2 Colleges and 1 New Professional College under Rashtriya Uchchatar Shiksha Abhiyan (RUSA).

Sir,

I am directed to refer the sanction of the President to release an amount of **Rs.15,52,50,000/- (Rupees Fifteen Crore Fifty Two Lakhs Fifty Thousand Only)** as the 2nd installment to be incurred to the State Government of **Arunachal Pradesh** as Infrastructure Grants to 2 Colleges and Grants to 1 New Professional College under Rashtriya Uchchatar Shiksha Abhiyan (RUSA) for the year 2017-18. The subsequent releases will be dependent on the submission of Utilisation Certificate for the earlier grants released.

2. Under RUSA, the Central Government shall provide assistance to the extent of 90% (in NER, J&K, Uttarakhand and Himachal Pradesh). The ratio of Centre to State share in the grants for **Arunachal Pradesh** is 90:10.

3. Subject to approval of the competent authority and fulfillment of all conditions as per RUSA norms, MHRD shall release **Rs.15,52,50,000/- (Rupees Fifteen Crore Fifty Two Lakhs Fifty Thousand Only)** of the allocation as the 2nd instalment of central share to the State Government of **Arunachal Pradesh**. Further instalments of the allocation shall be released by the Ministry only after the State Governments concerned releases of its committed share towards non-recurring expenditure and recurring grants, besides submission of the Utilisation Certificate by the State in respect of the second installment of the grant released.

4. The sanction is issued in exercise of the powers delegated to Ministries under DFPR, 1978, as amended from time to time. Above grants are being released in accordance with the pattern of Assistance approved by the Ministry of Finance, Government of India. It is also certified that this Sanction is being issued in conformity with the rules and principles of the scheme.

5. On receipt of sanction letter, the Principal Accounts Officer may issue an advice to the Reserve Bank of India (Central Accounts Section), Nagpur for affording credit of the sanctioned amount to the balance of the State Government. The Principal Accounts Officer may forward a copy of the advice to the Accountant General and Finance Department of the State Government as well as Director, Higher Education of the State with a copy to the undersigned. The State will then transfer these amounts along with its matching grant to the RUSA bank account of State Higher Education Council (SHEC).

10. A certificate of actual utilization of the grants received, for the purpose for which it was received, should be submitted to the Ministry within 12 months of the closures of the financial year.

11. The grant has been sanctioned in accordance with the pattern approved by the Ministry of Finance and is in conformity with the rules and principles of the scheme as approved by the Ministry of Finance.

12. Necessary Sanction ID has been generated.

13. This sanction issues with the concurrence of Integrated Finance Division's Dy. No. 4152/2017, dated 12.12.2017 and funds certified by the IF I Section vide their Dy.No.988/17-IF.I dated 14.12.2017.
