Sub:- Release of 1st installment of Grants to the Administration of **Andaman and Nicobar Island** as grants for Infrastructure to 3 Colleges under Rashtriya Uchcharat Shiksha Abhiyan (RUSA).

Sir,

I am directed to refer the sanction of the President to release an amount of **Rs.3,00,00,000/- (Rupees Three Crore only)** as the 1st installment to be incurred to the Administration of **Andaman and Nicobar Island** as grants for Infrastructure to 3 Colleges under Rashtriya Uchcharat Shiksha Abhiyan (RUSA). Under the initiative under reference, the Central Government shall provide assistance to the Administrations for various components, which are mentioned as per the guidelines under RUSA. The subsequent releases will be dependent on the submission of Utilization Certificate for the earlier grants released.

2. In accordance with the instructions of the Department of Expenditure, Ministry of Finance, Government of India, vide D.O.No.32/PSO/FS/2015 Dated 28th October, 2015 for Union Territories, the funding pattern is revised to 100% central share.

3. Subject to approval of the competent authority and fulfillment of all conditions MHRD shall release **Rs.3,00,00,000/- (Rupees Three Crore only)** of the allocation as the first instalment.

4. The sanction is issued in exercise of the powers delegated to Ministries under DFPR, 1978, as amended from time to time. Above grants are being released in accordance with the pattern of Assistance approved by the Ministry of Finance, Government of India. It is also certified that this Sanction is being issued in conformity with the rules and principles of the scheme.

5. As per instructions of the Ministry of Finance, Department of Expenditure vide their letter dated 31.01.2011, the procedure relating to payment of grants-in-aid by Central Government to the Union Territories without legislatures where accounts have been separated from Audit will be followed by issue of Direct booking of Expenditure against the final Heads of Account by PAOs of UTs on the basis of letter of authorization issued by Central Ministries/Departments. Accordingly, Pay & Accounts Office, Department of Higher Education, New Delhi will send a copy of the authorization to Pay & Accounts Officer, of **Andaman and Nicobar Island** Administration.

6. The grant-in-aid is subject to adjustment on the basis of audited statement of accounts of **Andaman and Nicobar Island**. Further, the accounts of the SHEC in so far as it relates to grants-in-aid will be open to inspection by the sanctioning authority and audit both; by the Comptroller & Auditor General of India or by any other designated by him and Internal audit by the Principal Accounts Office of the Ministry of Human Resource Development, Department of Higher Education, whenever it is called upon to do so.

The Administration shall maintain an audited record of all assets acquired wholly or substantially out of the scheme grants and these assets shall not, without the prior sanction Administration be disposed of, encumbered or utilized for purposes other than those which grants-in-aid are sanctioned.

Rs.22,50,000/- (ST) from : Major Head 2202- General Education, 03- University & Higher Education, 796- Tribal Area Sub Plan, 31- National Education Mission: Rashtriya Uchhtar Shiksha Abhiyan (RUSA), 01- Rashtriya Uchhtar Shiksha Abhiyan, 31-Grants-in-aid-General of the financial year 2016-17 (Plan).

9. Accordingly I am directed to convey the sanction of the President to release an amount of **Rs.2,32,50,000/- (Rupees Two Crore Thirty Two lakhs Fifty thousand only)** as the 1st installment to be incurred to the of **Andaman and Nicobar Island** as grants for Infrastructure to 3 Colleges under Rashtriya Uchchatar Shiksha Abhiyan (RUSA).

10. The expenditure of **Rs.2,32,50,000/- (Rupees Two Crore Thirty Two lakhs Fifty thousand only)** will be debited to Demand No.52-Department of Higher Education, Major Head 2202- General Education, 03- University & Higher Education, 102-Assistance to Universities, 25- National Education Mission: Rashtriya Uchhtar Shiksha Abhiyan (RUSA), 01- Rashtriya Uchhtar Shiksha Abhiyan, 31-Grants-in-aid-General of the financial year 2016-17 (Plan).

11. A certificate of actual utilization of the grants received, for the purpose for which it was received, should be submitted to the Ministry within 12 months of the closures of the financial year.

12. The grant has been sanctioned in accordance with the pattern approved by the Ministry of Finance and is in conformity with the rules and principles of the scheme as approved by the Ministry of Finance.

13. Necessary Sanction ID has been generated.

14. This sanction issues with the concurrence of Integrated Finance Division's Dy. No.1907/2016, dated 16-05-2016 and funds certified by the IF I Section vide their Dy.No.157/16-IF.I dated 25.05.2016.


