





The other areas where the grants could be made use of: Books and e-journals/ toilets/ automatic sanitary napkin winding machines/water coolers/interactive screens.



As per the Government Order read above, sanction was accorded for the implementation of Rashtriya Uchcharat Shiksha Abhiyan (RUSA), a Mission Mode project under the Government of India, across the State. As per the Government Order read as 2nd paper above, certain guidelines were issued regarding functions of Kerala State Higher Education Council (KSHEC) and the State Project Directorate (SPD), RUSA.

Now, it has come to the notice of the Government that certain provisions in the guidelines, issued in the Government Order read as second paper above, have created some confusion in certain quarters regarding the financial powers of the Vice Chairman, KSHEC. Government have taken cognizance of the same and are pleased to issue revised guidelines regarding the functions of Kerala State Higher Education Council (KSHEC) and the State Project Directorate (SPD) with respect to the implementation of RUSA.

Powers and functions of Kerala State Higher Education Council (KSHEC) with respect to RUSA

1. Planning, Preparing and Monitoring the State Higher Education Plan.
2. Creating and maintaining the Management Information System
3. Compiling and maintaining periodic statistics at State and Institutional level.
4. Evaluating State Institutions on the basis of norms under RUSA
5. Accreditation reforms
6. Managing the RUSA Funds, determining the methodology for transfer of funds and disbursement of funds to State Universities and Colleges.

Powers and functions of the State Project Directorate (SPD)

1. Overseeing project implementation at the state level.
2. Maintain statistical data and MIS reports.
3. Engage project auditors as required.

Methodology of work

The RUSA Project would be steered through KSHEC. The KSHEC would be supported in turn by the RUSA State Project Directorate (SPD) and State Technical Support Group (TSG). The Project Directorate and the Technical Support Group will be directly responsible for management, coordination, implementation and monitoring of the project at the State level. The TSG shall prepare the State higher education plan for RUSA in consultation with the State Project Directorate. It will be evaluated by KSHEC and forwarded to the Project Directorate for final approval. The State Project Directorate will in turn send the Plan to the RUSA Mission Authority.

Duties of State Project Coordinator

The State Project Co-ordinator shall aid and assist the State Project Director by working in tandem with KSHEC in the implementation of RUSA in the State. In addition, the State Project Co-ordinator is also entrusted with the following responsibilities.

1. Implementing higher education policies recommended by RUSA.
2. Conducting training programmes under RUSA
3. Interacting with the RUSA officials at the institutional level
4. Monitoring and supervising the usage of RUSA funds released to Universities, Colleges and other institutions.
5. Assisting the State Project Director in the evaluation of the State Higher Education Plan
6. Overall administration of the RUSA State Project Centre



I am directed to refer to the approval of the competent authority to release an amount of Rs.43,72,50,000/- (Rupees Forty Three Crores Seventy Two Lakhs Fifty Thousand Only) as 2nd installment of as Infrastructure Grants to 15 Colleges and 4 Universities at the central: state share of 60:40 to be incurred to the Government of Kerala, under Rashtriya Uchchatar Shiksha Abhiyan (RUSA). Under the initiative under reference, the Central Government shall provide assistance to the State Governments for various components, which are mentioned as per the guidelines under RUSA.

2. In accordance with the instructions of the Department of Expenditure, Ministry of Finance, Government of India, vide D.O.No.32/PSO/FS/2015 Dated 28th October, 2015 for General Category States, the funding pattern is revised to 60:40. Kerala comes under the General Category States. The Second installment of Infrastructure Grants to 15 Colleges and 4 Universities at the ratio of central: state share of 60:40 to be incurred to the Government of Kerala, under Rashtriya Uchchatar Shiksha Abhiyan (RUSA) amounts to Rs.43,72,50,000/- (Rupees Forty Three Crores Seventy Two Lakhs Fifty Thousand Only). Further installments of the allocation shall be released by the Ministry only after the State Government concerned releases its committed share towards non-recurring expenditure and recurring grants, besides submission of the Utilisation Certificate by the State in respect of the installment of the Central grant released.

3. The sanction is issued in exercise of the powers delegated to Ministers under DFPR, 1978, as amended from time to time. Above grants are being released in accordance with the pattern of Assistance approved by the Ministry of Finance, Government of India. It is also certified that this Sanction is being issued in conformity with the rules and principles of the scheme.

4. On receipt of sanction letter, the Principal Accounts Officer may issue an advice to the Reserve Bank of India (Central Accounts Section), Nagpur for affording credit of the sanctioned amount to the balance of the State Government. The Principal Accounts Officer may forward a copy of the advice to the Accountant General and Finance Department of the State Government as well as Director, Higher Education of the State with a copy to the undersigned. The State will then transfer these amounts along with its matching grant to the RUSA bank account of State Higher Education Council (SHEC).

SUBJECT: Review of RUSA Implementation held on 29th and 30th Jan 2016

Sir/Madam

This is with reference to the deliberations of the Rashtriya Uchchar Shiksha Abhiyan (RUSA) Zonal Review Meeting held at the India Habitat Centre, New Delhi on 29 to 30th January 2016, in which your State/UT was a participant.

As discussed in the review, RUSA financing is now moving from a system of base funding to one of performance-based funding. Accordingly, it has now become critical for States to take up intense and focused efforts for improving their RUSA implementation, especially in terms of fulfilling the non-negotiable actions that they had committed to when joining RUSA. It has also become essential for States to fulfill other important RUSA-related commitments within fixed time lines. These commitments are detailed below:

Compliance with conditionalities under RUSA

1. The State should take steps to ensure that SHEC is constituted by an Act of the State Legislature in accordance with RUSA guidelines at least by 31st March 2016. It is reiterated that SPD should be a member of the SHEC.
2. The State should ensure a fulltime SPD in accordance with the RUSA guidelines by 10th February 2016.
3. The formation and notification of TSG under the SPD should be ready latest by 10th February 2016.
4. The State Level Quality Assurance Cell (SQAC) for facilitating timely mandatory NAAC accreditation should be created and notified by

- 10th February 2016. The available pool of NAAC assessors should be considered while deciding the SQAC coordinator.
- 5. The State share of RUSA funding should be released to the RUSA account and in-turn to the beneficiary institution's bank account by 10th February 2016.
- 6. All RUSA funds released to the State have to be spent before 20th March 2016 and Utilization Certificates submitted by then. No revalidation of the already released funds would be considered or allowed.
- 7. The State should expedite filling of vacant faculty positions.
- 8. State should ensure implementation of academic audit in all RUSA beneficiary institutions. In this regard, it is requested to look at the academic audit conducted in the state of Andhra Pradesh as an illustration.
- 9. The State must expedite CBCS implementation (including at the Undergraduate level) and share with NMD a detailed roadmap for the same.

Monitoring and Implementation issues

- 10. Submission of DPRs (in the proper format with the required supporting documents) has to be done latest by 10th February 2016.
- 11. Photographs showing evidence of physical progress of RUSA works and videos of workshops etc. organized using RUSA preparatory grants have to be shared latest by 10th February.
- 12. Geo-tagging of RUSA funded institutions should be done latest by 10th February through the capturing and sharing of clear and relevant geo-tagged photos and attribute information through the Bhuvan RUSA android app. For this purpose the AISHE code would generally be the unique code for the Institutional Plans. Please visit http://bhuvan3.nrsa.gov.in/bhuvanapp_rusa.php
- 13. Documentation of work done under RUSA (summary of RUSA journey so far, including best practices) should be shared with respective State consultants in the RRC latest by 10th February.
- 14. States should share details of their RUSA bank accounts and beneficiary institution's bank account details by 5th February 2016. You may identify resource person for building capacities for PFMS (Public Financing Management System) and share the details with the consultants by 10th February 2016. State should further ensure that they are boarded onto the PFMS as on 1st April 2016 since all funds from the upcoming year (2016-17) will be transferred from the Ministry through PFMS.
- 15. States should mandatorily use RUSA logo in all activities/procurements/construction works and facilities created with the grants received under RUSA.
- 16. A robust State assesment and evaluation framework has been developed and shared with the States/UTs. The States had filled up and shared the framework with the RUSA Resource Centre. This practice of self filling and certification by States is encouraged under RUSA. However, these will be required to be validated by the TSG for accuracy and authenticity. The assesment and evaluation will be an important parameter for deciding future releases that are going to be performance driven.

Capacity Building and Leadership development

17. The State/UT is requested to send a participant list (10 nominees) for the Higher Education Leadership Academy (HELA) at the earliest, if not participated so far. The list may be shared with the Tata Institute of Social Sciences.
18. The State should build capacities to ensure collection, entry and maintenance of accurate data.


Preparatory Grant

19. The States have been provided preparatory grants to undertake preparatory activities by putting in place systems and processes for better implementation of RUSA. It has been observed that there has been limited utilization of preparatory grants over the last two years. States are encouraged to utilize their preparatory grants in accordance with the letter issued by the ministry dated letter no 4-17/2013-upolicy dated 16 March 2015 which details the activities for which the preparatory grants are to be utilized. The states are therefore requested to provide a roadmap for implementation of RUSA through the utilization of preparatory grants. It is requested that these grants maybe judiciously utilized and utilization certificate be submitted to the Ministry by 31st March 2016.

This Ministry will review the above-mentioned action points in February and, therefore, States are urged to comply with the above expeditiously.

An action taken in this regard is solicited.




