RUSA REPORT

Rashtriya Uchchatar Shiksha Abhiyan (RUSA) (National Higher Education Mission) is a Centrally Sponsored Scheme (CSS) to be



implemented through Ministry of Human Resource Development (MHRD) Govt. of India with matching contribution from the State Govts./UTs, launched in 2013 aims at providing strategic funding to eligible state higher educational institutions. The central funding (in the ration of 65:35 for general category States and 90:10 for special category States) would be norm based and outcome dependent. The funding would flow from the central ministry through the state governments/ union territories to the State Higher Education Councils before reaching the identified institutions. The funding to states would be made on the basis of critical appraisal of State Higher Education Plans, which would describe each state's strategy to address issues of equity, access and excellence in higher education. In a nutshell, the vision and mission of RUSA is to attain higher levels of **access, equity** and **excellence** (quality) in the State higher education system with greater efficiency, transparency, accountability and responsiveness.

In order to expedite the process of implementation of RUSA Scheme in the state, the following is mandatory compliance at institutional/college level:

- 1. Board of Governors (BoG) and Project Monitoring Unit (PMU)
- 2. RUSA Dedicated Account
- 3. GIS Mapping, Geo tagging & Photographic evidence
- 4. NAAC Accreditation
- 5. All India Survey on Higher Education IAISHE) Report

Board of Governors (BoG) and Project Monitoring Unit (PMU): In the institutional/college level BoG is the highest decision making authority

As on 10th August 2016 the college has received Rs. 11, 25,000 (Infrastructure Grant), Rs. 1,00,000 (Capacity Building Grant), Rs. 1,25,000 (State Matching Share), Rs. 10,41,666 (Equity Initiative, First Installment), Rs. 93,75,000 (Infrastructure Grant, 2nd Installment). Except, Equity Initiative and Infrastructure Grant (Second Installment) all the grants were utilized properly and utilization certificate were submitted to the proper authority concern.

Regarding the Infrastructure Grant (2nd Installment) amounting to Rs. 93,75,000/-, out of this Rs. 70,00,000/- shall be utilized for new construction. The new construction work shall be undertaken by M/S Lushai Engineer, Ramhlun South, Aizawl and the remaining balance, Rs. 23,75,000/is to be utilized for up-gradation/renovation of existing facilities or purchase of equipment with prior permission of the State Project Directorate (RUSA), Higher and Technical Education Department, Govt. of Mizoram. In this regard, the Project Monitoring Unit (PMU), RUSA comprises of:

 - 5. The resolution of the PMU meeting shall be conveyed to the Chairman, Building Committee for necessary action.
