## Government College, Pangti, Himachal Pradesh



GC Pangti is the interior and tribal most college of state and country as well. To reach Pangti itself is very difficult. This place remain disconnected to rest of the world maximum time as it falls between Sach Pass(16,000 ft ) and Rohtang Pass (12,500 ft) so roads are closed due to heavy snowfall for 6-7 months every year. Helicopters are used by staff /teachers to reach this place. This building has been constructed with the help of RUSA and state grants. In spite of difficult terrain, fragile weather and very less working days/season state has successfully completed the work here.
